ORDER:-

In the Government Order first and second read abc./e, orders were issued for the constitution of Appropriate Authority and Advisory Committee at District and Sub-District (Taluk) level for the implementation of the Prenatal Diagnostic Techniques (Regulation and Prevention of Misuse) Act, 1994 and for aiding and advising the Appropriate Authority in the discharge of its function respectively.

- 2. Representations have been received from various Women's Associations requesting interalia that Advisory Committees constituted at the District level for implementation of the Prenatal Diagnostic Techniques (Regulation and Prevention of Misuse) Act be broad based and that representation shall be given to representatives of Women's Association, Labour Unions, Consumer Forum and NGO so as to make them function effectively.
- 3. The Director of Medical and Rural Health Services who was consulted in the matter has felt that the modifications and additions are required in the pattern of the District level Advisory Committee and Sub-District level advisory Committee so as to be in consonance with the relevant provisions of the Prenatal Diagnostic Techniques

(Regulation and Prevention of Misuse) Act, 1954. Accordingly, the Director of Medical and Rural Health Services has sent proposals for the reconstitution of Advisory Committees at District and Sub-District (Taluk) level for approval of the Government.

- The Government, after careful examination, accept the proposal of the Director of Medical and Rural Health Services.
